# SECTION D

### TECHNICAL SPECIFICATION FOR ANIMATION EDIT SYSTEM

## Scope of Work

This project will install a new Rendering Farm to replace the existing system located in two separate buildings at the Bergen Community College Campus. The awarded vendor must remove all existing equipment (see section IV. #6 of the technical specifications for details), then install the new systems as per the specifications listed below. There are three computer system components;

- The animation Edit system. (Quantity 1) Located in the Technology Building in the Tec-102 Classroom Lab. This stand-alone computer will collect all the rendered frames and construct a timeline and ultimately produce the completed animation of the student projects. See section I. below for detailed specifications.
- Render Nodes. (Quantity 10) Located in Pitkin Hall, Room B-116. These computers are specifically for rendering each frame of the animation projects. See section II below for detailed specifications.
- 3. The Render server. (Quantity 1) This computer will be located in the college's mainframe room (B-116) in Pitkin Hall. This will be installed in a rack system and will manage and store all the rendered frames (files) produced by the students. See section III. of the technical specifications for details.

The awarded vendor must have deep knowledge of all the hardware and existing peripherals (see section I. #14 and #15 of the technical specifications) to configure all the equipment. A one-year warranty and support contract (see section IV. of the technical specifications) is also included in this project.
