**Term of Agreement:**

The term of this agreement will be for three (3) years.

**H. Certificate of Public Convenience and Necessity.**

In accordance with N.J.A.C. 7:26H-1.6, no person shall engage in the business of solid waste collection or solid waste disposal unless such person is the holder of a certificate of public convenience and necessity issued by the New Jersey Department of Environmental Protection ("NJDEP"). Further, no person shall bid for a solid waste collection or solid waste disposal contract with a New Jersey public entity, or commercial or industrial entity, unless that person is the holder of a certificate of public and convenience. Therefore, bidder shall submit with its bid a copy of its Certificate of Public Convenience and Necessity issued by NJDEP.

**I. Recycling Reports to be Provided As and When Requested.**

As and when requested by the College, the successful bidder shall timely provide recycling reports demonstrating, at a minimum, the amounts and types of materials recycled from source-separated and commingled recyclables collected at the College

**J. Disposal/Recycling Facility.**

In furnishing all labor, material and equipment required for the collection, disposal and recycling of the designated solid waste, Contractor will be required to utilize transfer station or disposal facilities that are fully permitted under all applicable law and copies of all required authorizations to operate the transfer station and disposal facilities must be provided with the Bid. Contractor shall have the option to recover materials from the solid waste but will be required to report all recovered material quantities by material type to the College. Materials recovery must be an approved operation pursuant to the disposal facility's or transfer station's Solid Waste Facility Permit. Any recyclable items as specified herein shall be the responsibility of the Contractor to remove from the designated solid waste stream, and Contractor shall be fully responsible for the ultimate processing of these recyclable materials. Accordingly, the Contractor shall be entitled to keep all proceeds from the sale and lawful disposition of such recyclable materials.
